J. Administration – Information Reports

1. Curriculum Instruction and Technology

Mrs. Veazey presented to the Board the opening day gift along with the calendar and a technology passport. She also highlighted new teacher information. She stated that they provided a Technology boot camp for the 11 new teachers. Mrs. Veazey stated that the teachers were very impressed about how many miles our district covers. She stated that each teacher received a basket worth about \$200.00 to start setup in their classrooms.

Mrs. Veazey stated that she received a phone call from Renee Jefferson the artist who spearheaded the current art collage at the junior high. She informed her that there is a group call Diasporal Rhythms who invited our Junior High School to participate in their group. She stated that they want to bring a group out to the school in October. She stated that this is the first time they have done anything in the South Suburbs. She stated that they did a photo shoot on our art piece that was created by the students for the Jr. High.

There was a question about the network security. Mrs Veazey stated that there was no breach in our system. She stated that the district is going to add another layer to the network security. Dr. Patterson stated that it will cost the district about \$20,000.00.

2. Business Affairs and Human Resources

Mrs. Sharpp informed that Board that she has finalized the year end process with the Treasures Office. She stated that she is working on the Teachers Retirement Services report and that she has finalized the tentative budget.

She stated that building and grounds installed a 6-foot fence on the baseball field. Ms. Sharpp stated that the paving projects are 100% complete. She additionally stated that she will be inspecting the buildings to ensure they are ready for opening day.

3. Student Services

Mrs. Ablin stated that the concussion manual was completed. She stated that online registration was completed and there are currently 1,981 students registered. She stated that the Back to School Celebration was on Saturday, August 13, 2016 and there was a very good turnout.
